The Dangerous Substances and Explosive Atmospheres Regulations (DSEAR) 2002 require businesses to manage and control risks associated with hazardous substances. These regulations protect employees and the public from fires, explosions, and structural damage caused by dangerous materials. DSEAR applies to workplaces handling substances such as flammable liquids, compressed gases, and combustible dusts.
